CONTEST PRIZES

The winning picture/drawing being featured as the Face of the New Children's Bridge website!

The winner, and follow-up 11 finalists would all receive their picture in a frame accompanied with a gift card as a thank you for entering the contest. The remaining 11 finalist's art work could be featured within the Website as well as within the Children's Bridge Monthly updates in the 2018 year and beyond.

HOW TO ENTER

Easy-peasy:

- 1) Draw a picture of you and your family;
- 2) It should be using crayons or coloured pencils on an 8 x 11 piece of paper;
- 3) Done. (If you like, repeat! You can enter as many pictures as you like.)

Children's Bridge Website Colouring Contest runs from July 15, 2017 to September 30, 2017. The winning picture/drawing will be chosen by the Board of Directors and Staff of the Children's Bridge, from 12 finalist drawings in early October 2017. FULL CONTEST RULES & REGULATIONS

The Children's Bridge Drawing Contest (the "Contest") is brought to you by the Children's Bridge (the "Sponsor"). The Contest starts on July 15, 2017 at 12:01 a.m. EST, and closes on September 30, 2017 at 11:59 p.m. EST (the "Contest Period").

1. Eligibility

The Contest is open to all Children's Bridge families and their immediate relatives. The contest is open to all children up to 12 years of age.

Employees and contractors of the Children’s Bridge, and members of the immediate family (parents, children, siblings and spouse, regardless of country of residence) of any of the aforementioned and persons are not eligible to enter the Contest.

2. How to Participate in the Contest

NO PURCHASE NECESSARY.

Entry is via a drawing of your family, as many as you would like to send to The Children’s Bridge office.

3. Prize

There is a total of one (1) grand prize (“Grand Prize”) selected from 12 finalist entries.

3.1 The Grand Prize

The Grand prize winner’s drawing/picture of his/her family would be published on the new Children’s Bridge website.

3.2 The Finalist Entries

The eleven (11) finalist Entries will be featured throughout a 2018 monthly update calendar being produced by the Sponsor, 2 copies of which will be provided to the finalist Participants.

4. Judging and voting

Judging consists of one (1) round of evaluation and one (1) round of voting. Evaluation will be done by Sponsor Representatives including Incomplete and/or inaccurate entries and entries not complying with all the rules are subject to disqualification. Decisions of the Judging Panel are final and not subject to appeal.

5. Prize Attribution

Finalists will be notified by email by October 10, 2017.

Before being declared a winner, each selected Eligible Participant will be required to sign a release and waiver form confirming, without limitation, that:

- He/she complies with the eligibility requirements;
- He/she has read the Contest rules and regulations and complies completely;
- He/she accepts the Prize as awarded;
- He/she acknowledges the Contest Sponsor’s right to publish his/her picture, name and city of residence without compensation other than the Prize offered;
- He/she releases and agrees to hold harmless of all liability the Contest Sponsor, Promotional Partners, its subsidiaries and affiliates, media partners, advertising, promotional agencies and each of the foregoing entities’ directors, officers, employees, contractors and agents.

6. Conditions for Participating

The Contest is open to all adoptees from The Children's Bridge, up to 12 years of age.

By entering the Contest, Participants represent and warrant that the Contest Entry is an original work, and does not violate any third party's proprietary or intellectual property rights. If the Contest Entry infringes upon the intellectual property right of another, the Participants will be disqualified at the sole discretion of The Canadian Fuels Association. If the Contest Entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, the Contest Participant shall, at his/her sole expense, defend or settle against such claims; the Contest Participant shall indemnify, defend, and hold harmless the Sponsor and Promotional Partners from and against any suit, proceeding, claims, liability, loss, damage, costs or expense, which a Participant may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.

By entering the Contest, Participants agree to provide the following rights to The Children's Bridge: (1) Perpetual, continuous, irrevocable, non-exclusive, unrestricted worldwide right to the Contest Entry in any media of the Contest Sponsor (including, without limitation, digital and broadcast formats, whether now known or hereafter developed) for editorial and content marketing purposes (2) The right to use the Contest Entry, your name and biographical information, to promote the Contest Sponsor's media and other services and publications and use the Contest Entry in perpetuity for internal business purposes, such as awards, publicity and similar purposes; (3) The right to publish the Contest Entry on any social media, in whole or in part.

You agree to defend, indemnify and hold the Contest Sponsor and its Affiliates and their respective directors, officers, employees, ("Indemnified Persons") harmless from and against all costs, losses and expenses of any kind, including reasonable legal fees, resulting from or relating to: (i) any breach by you of the representations and warranties or obligations hereunder; (ii) damages to personal property, injury or death caused by your negligence or willful acts; (iii) any claim brought against any Indemnified Persons that any Work infringes any third party's intellectual property rights or other rights; and (iv) any and all liability or damage incurred by Bookmark, the Client and its Affiliates as a result of your performance of this Agreement.

7. General Terms and Conditions

All Eligible Entries, and all information provided by Eligible Participants must be complete and accurate. Contest Sponsor will not be held responsible for any and all telephone or internet problems, unclear e-mail messages and any late/incomplete/erroneous prize claims.

All entries are subject to verification by the Contest Sponsor and may be disqualified if they are received outside of the Contest Period, are incomplete, illegible, irregular, photocopied or otherwise reproduced, submitted through illicit means or if they contain any false statements, or do not conform to or satisfy to any condition of these Contest rules and regulations.

Eligible Participants agree that the Contest Sponsor and Promotional Partners are not liable for any incorrect or inaccurate transcription of entry information or for any error or malfunction of any kind in connection with the Contest. If the Contest is not capable of running as planned for any reason, including tampering, unauthorized intervention, fraud, technical failures, or any other cause, the Contest Sponsor reserves the right, at its sole discretion, to, without advance notice, terminate or suspend the Contest, in whole or in part, or modify it in any way, without any further obligations to

Eligible Participants. Furthermore, if the Contest Sponsor determines, at its sole discretion, that any entry compromises the integrity of the Contest, the Contest Sponsor further reserves the right to disqualify the entry at issue or terminate the Contest in its entirety without any further obligations to Eligible Participants. The Contest Sponsor further reserves the right, at its sole discretion, to disqualify any individual from the Contest and to ban the individual from any future contest of the Contest Sponsor who finds or believes to be tampering with the entry process operation of the Contest; to be acting in violation of the Contest rules and regulations or in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.

The Contest is subject to federal, provincial and local rules and regulations. By entering this Contest, Eligible Participants expressly consent to the Contest Sponsor, media partners, advertising and promotional agencies, storing, sharing and using the personal information submitted with his/her entry only for the purpose of administering the contest and in accordance with the Contest Sponsor's Privacy Policy.
